

GENERAL INFORMATION: Our show hall is Leesport Farmer's Market, 312 Gemant's Church Road, Leesport, PA 19533 610-926-1307, www.Leesportmarket.com.

Excellent people food will be available in the show hall. The show hall is heated and handicapped accessible. No smoking or vaping is allowed in the show hall. Reasonable care will be taken of cats and personal property but show management and Finicky Felines Society are not liable for loss, injury or damages.

HOTEL: Microtel by Wyndham, 50 Industrial Drive, Hamburg, PA 19526 Phone: 610-562-4234 has a block of 23 rooms at \$94 double, with pet \$30 pet fee. **MUST** call hotel directly, say you are with Finicky Felines January Group. Block will be held until December 31, 2025, but rooms will be available at club rate **IF** they have them after December 31, 2025.

CHECK-IN: 7:30-8:30 AM. Any cat not benched by 8:30 will be marked absent. Judging will begin **PROMPTLY** at 9:00AM. Advertised closing time is 4:00PM. Cage size is approximately 22"x22"x22" and is included in your entry fees. Bring cage curtains (or coverings) to cover the sides, top and bottom of the cage. Please inform the entry clerk if you have your own security cage. Litter will be provided, but not litter pan. *Exhibitors with single entry using any size security cage are required to purchase an extra half cage space.

SCORING: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers but will not be scored for CFA awards if a number is not provided at show time. Kittens without a registration number or TRN will be included in the count.

HEALTH: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against panleukopenia, feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. The exhibitor of any entry showing evidence of fungus, fleas, ear or any contagious disease will be asked to remove entry as well as other from the show. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition. Finicky Felines Society reserves the right to substitute judges in case of illness or emergency. By entering exhibitors agree to abide by the decision of all judges and the show committee and adhere to CFA show rules.
